PRIVACY POLICY

SCADA International understands the importance of protecting your personal data. SCADA International will not give or sell any information that is collected from our web site to any third party, except as required by law. Any information received from this site is for the exclusive use of SCADA International. This policy, last updated on 10th September 2019, describes our general privacy practices.

We take your data protection seriously

SCADA International is a data controller. We collect data concerning you and process it in accordance with current legislation. If you wish to contact us regarding our processing of personal data, please mail scada@scada-international.com or telephone +45 9641 9200.

Processing of personal data

Personal data is every kind of information which in some way, can be assigned to you.

As a customer, supplier or business partner, the following personal data is collected:

- Your name
- Your e-mail address
- Your telephone number
- Your position

When you make use of our website, we collect and process different kinds of information. For instance, when you access content, sign up for a newsletter or request information.

How we use personal data

Personal data about customers and potential customers is collected for the following purposes:

- Responding to your request for information
- Processing your order or request for support
- Managing your relation with us
- Processing purchases/services

Also, we will use the information collected to help in the on-going development of the SCADA International web site.

Security

We have taken the necessary technical and organizational measures to prevent your data from being deleted, released, lost or impaired accidentally or illegally. Similarly, technical and organizational measures have been taken to avoid your data from becoming known to unauthorized persons, or in any way being processed against the legislation.

Recruitment

All applications and relevant appendices are stored in SCADA International's HR system. Access to CV's and application content are limited to HR and Hiring managers only, with the purpose of qualifying candidates and answering applications. CV's and appendices are deleted immediately after completion of the hiring process for each position and no later than six months. CV's are only stored after the hiring process if consent has been given from the candidate and never more than six months.

Data minimization

We only collect, process and store the personal data necessary to fulfil our purpose. What type of data is required to collect and store in connection with our business practice may be determined by law. The nature and the extent of the personal data we process can be determined by the need to comply with a contract or any other legal obligation.

Data is updated

Since our service depends on correct and up to date data, we ask you to inform us about relevant changes in your personal data. Please contact your SCADA International representative, use the contact information above, or make use of the contact form on our website. If we notice that any data is incorrect, we will update the data and inform you.

Storage period

Data is stored in the period allowed according to current legislation, and as long as the legal entity or contact person has not asked for deletion. Data is deleted when it is no longer necessary. The period depends on data character and the basis for storage.

Consent

When you consent to receive newsletters about SCADA International products, case studies and other news, or request information, you do so voluntarily. Passing on data

We use third-party IT suppliers to store and process data. They only process data on our behalf and may not use the data for their purposes. In relevant cases, data is given to banks, transport companies, and debt collectors.

We will only pass on data such as name, e-mail, etc. for other purposes if you give your consent.
